Explained the rules to assume a home on a vacant lot. Explained that in the absence of rules for participants, Capital Power was trying to do the following: <ul style="list-style-type: none"> 45dBA max from the cumulative noise model, and that it was chosen in part from old regulations and in part from some international rules. In very few cases where Capital Power could not meet 45dBA and have to lose the turbine, Capital Power reviewed with the landowner to see if they were okay with the location. Lease options have provision for landowners to make special requests, such as proximity that they would accept. Reviewed all locations with the landowners and were prepared to move or eliminate a turbine if the landowner felt it was too close to their home. Stated that Capital Power does not want "landowner regret" and strives to ensure they understand exactly what is being proposed.
